We would like to provide the factual details for the sake of clarity and accurate record.

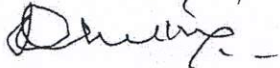

As the transformer is now outside its warranty period, the supplier submitted a rectification offer to us on 13th October 2025.

We have initiated necessary action for rectification of the problem by ourselves with the help of other known Agency. We wish to state that the transformer break down is a normal feature of wear and tear. Further, please note that the notification provided to the stock exchanges is strictly intended as a clarification on this matter.

We wish to add that we have long association with TARIL and are happy with their services.

We hope this clears up any confusion and assures all stakeholders.

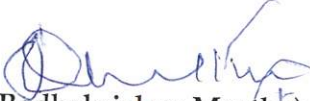
